

COUNTY GUIDELINES FOR MISDEMEANOR TRANSFERS

BAKER	Person to person only and Sex Offenders, but only if reciprocal.
BENTON	Person to person A , DUII and Sex Offenders.
CLACKAMAS	Person to person, DUII and Sex Offenders, but only if reciprocal. No Felony Diversions.
CLATSOP	No misdemeanor transfers.
COLUMBIA	<u>Case by case:</u> Partner to partner DV, but only if reciprocal. Contact PO for consideration)
COOS	<u>Case by case:</u> Person to person & 3 rd DUII (Contact Director for consideration)
CROOK	Sex offenses only.
CURRY	No misdemeanors.
DESCHUTES	Sex Offenses /DV Assault IV, other DV Misdemeanor- call for consideration.
DOUGLAS	No Misdemeanors. No Felony Diversions
TRI-COUNTY GILLIAM/ SHERMAN/ WHEELER	All misdemeanors.
GRANT	No misdemeanors, unless accompanied by a Felony. If the Felony expires before the Misdemeanor the county will not continue supervision.
HARNEY	Person to person only.
HOOD RIVER	All misdemeanors.
JACKSON	No misdemeanors.
JEFFERSON	Person to person only.
JOSEPHINE	All Misdemeanors.
KLAMATH	DV Person to person and sex offenses only, but only if reciprocal.
LAKE	DV Person to person and sex offenses only, but only if reciprocal.
LANE	No misdemeanors, unless accompanied by a Felony.

LINCOLN	<u>Case by case:</u> Person to person only (Contact PO for consideration) No Felony Diversions
LINN	Sex offenders only.
MALHEUR	Person to person, but only if sending county accepts same
MARION	8 County Agreement and all Misdemeanors if reciprocal.
MORROW	No Misdemeanors.
MULTNOMAH	Case by case - call Intake Office, 3 in 10 yr DUII, Partner to Partner DV and Sex Offenders.
POLK	Sex Offenses only.
TILLAMOOK	Person to person, DUII & sex offenses.
UMATILLA	No misdemeanors.
UNION/ WALLOWA	Person to person /Sex Offenders.
WASCO	No misdemeanors. No Felony Diversions.
WASHINGTON	All misdemeanors.
YAMHILL	Sex offenders/DV-Assault IV, Strangulation, Menacing, Harassment/ Assault IV/ Endanger Minor/Sexual Harassment/ 2 nd DUII/ Animal Abuse-Neglect ONLY (Will no longer take 1 st DUII and all other Misdemeanors.)
