On June 29, 2008, the minimum and maximum weekly benefit amount increased to:

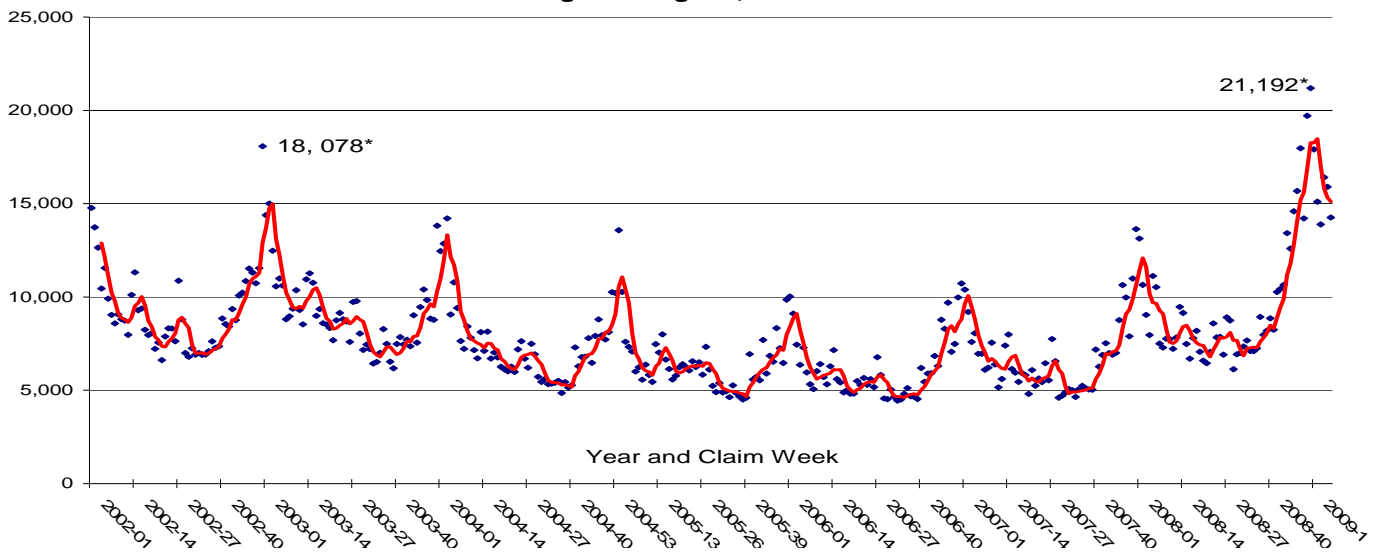
