A public-private partnership to improve Child Care in Oregon

(Revised May 28, 2009)

Concept

EQUIP is an innovative public-private partnership aimed at improving the quality of child care, strengthening the early care and education workforce and preparing Oregon's youngest children for success in school.

History

EQUIP is the result of an effort that began in 2008 when state agencies and private organizations came together to create a strategy to raise the quality of early care and education in Oregon. State agencies including the Child Care Division, the Department of Human Services and the Oregon Department of Education-Head Start Collaboration Office worked with The Oregon Community Foundation, the Commission for Child Care, the Children's Institute, the Oregon Child Care Research Partnership, the Oregon Child Care Resource and Referral Network and the Center for Career Development in Childhood Care and Education at Portland State University to create EQUIP. The Commission for Child Care listed EQUIP as a priority and will provide the oversight and accountability to the EQUIP initiative.

Funding

Initially, EQUIP will be funded by \$2.9 million in federal stimulus funds designated to improve child care quality. The partnership is working to create an ongoing funding strategy, anchored by a \$200,000 commitment from The Oregon Community Foundation. The funds from the federal stimulus are specifically designated for projects that improve the quality of child care.

Strategies

EQUIP utilizes multiple strategies that support both individuals and facilities. First, by offering early childhood professionals incentives to continue their education, EQUIP will help build the skills and competencies of Oregon's early childhood workforce. A better prepared early childhood workforce means better outcomes for children and families. Secondly, a program now in development, focuses on program-level improvements. By providing early care and education programs with evidenced-based benchmarks and technical assistance for achieving them, EQUIP will help programs improve their quality. While participation will be voluntary, EQUIP will provide attractive incentives to make quality improvements possible.

Project Work

EQUIP requires multiple projects to achieve the desired outcomes. An overarching principle of EQUIP is to strengthen and utilize the existing child care infrastructure to support the various components. Several projects are required to support this initiative and are listed on the previous page according to the components they support along with the lead partner and implementation timeline.
